Dear Kentfield School District (KSD) Community:

On behalf of the KSD Board of Trustees, I want to thank you for your patience and partnership as we have collectively navigated the uncertainty and impact of COVID-19. We've spent these last few months fluidly accepting updates from our Public Health officials and wondering what the future of our school programs might look like.

Yesterday, June 18, the [Marin Public Health](#) and [Marin County Office of Education](#) issued [A Public Health Guided Return to Site Based Instruction \(Spanish language version\)](#), which provides us maximum flexibility with serving students directly on site. As we digest this information we are taking into account feedback from all our stakeholders to inform what is best for our KSD community. As shared at the [June 18th Office Hours](#), we recognize that Distance Learning may have been a challenge for members of our community. So, as we move into this next phase, we want to carefully and methodically outline an instructional plan that embraces the necessary safety protocols outlined by Public Health while offering an educational program that is conducive for all our students.

As previously shared, I am committed to continuing to update our community and offer a forum to respond to questions and concerns via District Office hours throughout the summer months (Thursdays at 4:00pm - link provided below). My hope is that prior to the end of the month I will be able to share the instructional programming we plan to implement in the fall, as well as the final school safety guide for school operations.

Please know we appreciate your engagement and patience in this process as we all have the common goal of doing what is best for the safety and well-being of our students and staff.
